For example: We are unable to carry out preliminary checks on placements nationwide ourselves, which is why preliminary checks are occasionally carried out by animal welfare colleagues from other organisations. In this case, they also sign a corresponding data protection form regarding your data.

You have the right to receive information about the recipients and purpose of your stored personal data free of charge at any time. Additionally, you have the right to request the correction, blocking or deletion of this data.

There is a statutory retention period for some data. In this case, the statutory regulation takes precedence. We will immediately delete your data once this period has expired.

Tierfreunde Lesbos e.V. takes the protection of your personal data very seriously. We treat your personal data confidentially and in accordance with the statutory data protection regulations - GDPR - and this privacy policy.

Many data processing operations are only possible with your express consent. You can revoke your consent at any time. All you need to do is send us an informal email. The legality of the data processing carried out until the revocation remains unaffected by the revocation. Deletion due to cancellation is always possible within the framework of the statutory retention periods.

In the event of breaches of data protection law, the data subject has the right to lodge a complaint with the competent supervisory authority.
